Meet the Team event, July 2024



Your feedback

Thank you to everyone who attended our July 2024 event, where Archio gathered your feedback on their initial ideas.

Some of the early designs included areas not previously considered for new homes. We aimed to present the full range of ideas being explored and discuss the benefits and compromises with residents.

Feedback on these ideas was mixed, reflecting their impact on individual residents. While some supported new homes in various locations, others were concerned about the concept of new housing overall.

Key themes from your feedback:



Parking and storage replacement

Users of these facilities requested more clarity on how/if these would be replaced if built on.



Security

Security is a key concern for residents. Ideas for improving security and limiting access to the central area were preferred.



Site analysis

We received useful feedback on how the estate works now. The next round of design ideas will be informed by these themes and your insights.

Estate repairs

There are ongoing concerns about unresolved repairs and maintenance. We have been speaking with our colleagues in Repairs to find a way to address these issues.

Online feedback summary

Following this event we received further emails, surveys and letters sharing resident opinions.



Resident Feedback Group Q&A

What is the purpose of the group?



The group offers residents a chance to discuss designs with neighbours and the council in a focused setting. The council will present materials and share feedback with the design team. This is not a codesign activity but an opportunity to share and discuss feedback. Group members will have the same influence over designs as the wider community.

When will they meet?

Meetings will last about an hour and take place a few days before each event, estimated for early November 2024, Winter 2025, and Spring 2025. Dates will be agreed with members in advance. Meetings will be on a week night, either virtual or in-person, based on preference.

Who will be part of the group?

We are looking for 8 people to commit to all three meetings, with a representative mix of council and private residents.

- 3 residents from Bernard Shaw Court
- **3 residents from Foster Court**
- 2 residents from neighbouring properties. •
