


# We are updating details on parking and storage usage

Over the past few weeks residents who rent a garage, car park or storage on the estate received a survey about how they use their space. Thank you to those who have returned these so far - this information will help our team with options and approaches for potential reprovision.

### **Resident feedback group**

Thank you to the residents and neighbours who applied to be part of this group. Applications were anonymously reviewed and we have assembled a group of 9 people representing:

- 3 residents from Bernard Shaw Court
- 3 residents from Foster Court
- 3 residents from neighbouring properties

Following feedback from estate residents and Councillors, we added an additional space to the neighbouring properties group to even out numbers. All applicants have now been notified of the outcome and our first meeting will be held prior to the next event.

You can now report non-emergency repairs by texting 07360 277909 in your preferred language. Text us any time, and we will reply from 8am to 6pm Monday to Friday excluding Bank Holidays.

If you have a question or need advice about a housing repair, you can talk to us instantly and upload pictures of your repair. Talk to a real person to answer questions or book a repair, from **Monday to Friday, 8am to 6pm**.
